2.15–2.45pm	The Poisons Act 1972 and Control of Explosives Precursors and Poisons Regulations 2023 – Industry compliance Dr John Sandford O'Neill, Chemical Security Lead, Homeland Security Group This presentation is brought to you by the Explosives Precursors Engagement Team who support policy work across government to counter terrorism threats and support the Homeland Security Group (HSG) policy leads in delivering counter terrorism and national security objectives. Specifically, the team works to prevent and detect terrorist acquisition of substances (chemical, biological, radiological and explosive) and to reduce the vulnerability of sites holding them. As of 1 October 2023, regulations around explosives precursors and poisons as defined in the Poisons Act 1972 were tightened. This was in response to the Manchester arena bombing where 22 people lost their lives in May 2017. This presentation will provide attendees with a refresh of those legislation changes, an opportunity to ask questions and an overview of what the team does and how they may be able to help your business with compliance.
